5. NEXT STEPS

In the next five (5) business days upon receiving this form, TCA Agents will:

- a. Validate the information provided in Section 1 against trusted public sources. (If TCA Agents find missing information, or pieces of information that require additional validation, they may reach out to you to request additional information or documentation.)
- b. Call the CA callback phone number provided in Section 1 to validate the authorization of the Representative listed in Section 2.
- c. Schedule a video call with the Representative to validate their identity and government-issued photo ID.

On the successful completion of these steps, TCA Agents will notify the Representative and the Organization's Primary Contact of the OV results. The OV status lasts for 398 days; the Organization should resubmit the OV form with ample time before the OV status expires to ensure continuity of service.
